

## **Application Bootcamp Terms and Conditions**

By enrolling in the Application Bootcamp ("the Bootcamp"), you agree to the following terms and conditions:

**Eligibility:** The Bootcamp is open to rising high school seniors who are applying to colleges in the upcoming application cycle.

**Personal Statement Essay Editing:** Participants will undergo two personalized evaluations of their personal statement essay as part of the Bootcamp curriculum. The initial review will occur during the Bootcamp sessions. The second review can be requested up to one week following the conclusion of the Bootcamp. No reviews will be conducted beyond this timeframe, and the organizers bear no responsibility if participants fail to submit their essays within the specified period. Organizers commit to returning edits within 72 hours of receipt. The feedback, presented in written and/or video format, may encompass content, structural, and grammatical suggestions. Although not providing a line-by-line edit, these evaluations are intended to offer actionable insights to aid participants in refining their essays. It is expected that students will continue to revise and edit their personal essay after the Bootcamp to finalize it.

**Registration/Payment:** Payment for the Bootcamp is due upon registration and must be made in full. Payment plans or financial aid options are not available. Payments can be made by credit card, PayPal, Venmo, or Zelle. Registration is not complete until payment has been received. After registration is complete and payment has been received, participants will receive an email from Summit College Advising acknowledging enrollment in the course.

**Participation:** Participants are expected to attend all sessions of the Bootcamp. We will not provide make up sessions. Session information will be recorded and provided to all registered participants. Participants are expected to effectively manage their time during the camp, dedicating themselves to completing the day's assignments and addressing any unfinished tasks as homework. Organizers cannot be held accountable for participants who fail to make efficient use of their time.

**Technology Requirements:** Participants are responsible for ensuring they have access to the necessary technology for the Bootcamp, including a stable internet connection, a computer or tablet with audio and video capabilities, and access to any required software or online platforms. The organizers are not responsible for any technical issues experienced by participants during the Bootcamp sessions.

**Materials:** Participants will receive access to resources such as brainstorming activities and a college application organizer. These materials are for personal use only and may not be distributed or reproduced without permission.

**Conduct:** Participants are expected to engage respectfully with instructors and fellow participants. Any disruptive or inappropriate behavior may result in removal from the Bootcamp without refund. Participants are expected to have their camera on during the sessions.

**Cancellation and Refunds:**

*Cancellation by participant:* Participants may request a full refund up to 14 days before the start of the Bootcamp. No refunds will be issued after this time.
