

## **Rising Senior Parent Workshop Terms and Conditions**

By enrolling in the Rising Senior Parent Workshop ("the Workshop") you agree to the following terms and conditions:

**Eligibility:** The Workshop is open to parents or legal guardians of high school juniors who are planning to apply to colleges in the upcoming summer/fall application cycle. Parents with younger students are also welcome to participate.

**Registration/Payment:** Payment for the Workshop is due upon registration and must be made in full. Payment plans or financial aid options are not available. Payments can be made by credit card, PayPal, Venmo, or Zelle. Registration is not complete until payment has been received. After registration is complete and payment has been received, participants will receive an email from Summit College Advising acknowledging enrollment in the course.

**Participation:** Participants are expected to attend all sessions of the Workshop. We will not provide make up sessions. Session information will be recorded and provided to all registered participants. The Q&A portion of the session will not be recorded in order to encourage open dialogue.
